MAKING A RESERVATION

Don't be afraid to book ahead – our cancellation policy lets you make changes up to 3 days before arrival.

Reservation Confirmation & Payment

A valid credit card is required for all rentals. Upon receipt of valid credit card information at the time the booking is confirmed, a "Rental Agreement/Confirmation" will be emailed* to the cardholder.

We take the protection of your personal information seriously, and recommend that you phone our office at 250-982-2146 with your credit card information for security purposes. No charges are taken prior to the actual day of rental.

***Note:** Your reservation is **not** confirmed unless you have received a "Rental Agreement/Confirmation" via email from Bella Coola Vehicle Rentals.

Cancellation Policy

For all rentals, our policy is 2 days charged, (or the term of the rental, whichever is less), if cancelled within 72 hours of the date of rental. **Full rental may be charged if cancelled within 48 hours**, at our discretion. We reserve the option to substitute vehicle types if necessary. Four-wheel drive units (4x4) will be provided as requested notwithstanding circumstances beyond our control.

Insurance

Insurability is Totally Dependent Upon Drivers Operating Within Applicable BC Laws

Drivers must possess a license valid for passenger cars and trucks in British Columbia. Foreign license holders must ensure they are legally able to operate passenger vehicles in BC.

By taking possession of, and/or operating any of our vehicles, the client is verifying that the driver is legal to operate the vehicle in British Columbia.

Coverage

- collision deductible \$300
- comprehensive deductible \$300

Airport Vehicle Pick-Up on Arrival

To provide efficient, safe, and convenient service, your travel and payment details have been collected in advance. Therefore, you can literally ***grab your keys and go*** when you arrive via air at the Bella Coola airport. Our office is to the left as you enter the Bella Coola terminal from airside. Take a right turn at the opposite end of the passenger lounge. The office door is on your left.

Returning Your Rental

When returning your rental, please fuel your vehicle and leave it locked in the airport parking area. If our office isn't staffed, please return the key to the **'Key Drop Box'**, which is located on the wall beside our inside office door.

Travel Restrictions

All clients are required to sign a 'Restricted Roads Acknowledgement' confirming that they will NOT travel on the following ***Forest Service Roads (FSR)***:

- ***The Tweedsmuir Tote Road, providing access to the Stillwater Lake/Hunlen Falls Trail;***
- ***The Nusatsum FSR, providing access to Odegaard Falls/Ape Lake/Purgatory;***
- ***The Clayton Falls FSR, providing access to Blue Jay/Grey Jay/M. Gurr Lakes;***
- ***The Telchako FSR, access from McCall Flats Road***

Past experience has evidenced major damage and repair costs to our vehicles travelling these unmaintained roads. The resulting expense and risk of personal harm has convinced us to restrict such travel and levy a **penalty of \$750** if this restriction is violated.

SURCHARGES AND FEES

Delivery and Drop Fees

With advance notice, vehicles may also be delivered to, or picked up from the Bella Coola Harbour, local hotels, or other locations. There is a fee of \$45.00 + GST each way for this service.

Mileage

Mileage is included to a daily limit of 150kms for travel within the designated travel area (Bella Coola to Nimpo Lake). Travel beyond the designated travel area requires advance notification and arrangement. Mileage above the daily allowance is charged at \$0.58/km. Fixed round-trip rates can be arranged for travel outside of the designated travel area.

Fuel Charges

It is our policy to provide vehicles full of fuel, and our expectation is that they be returned in the same condition.

It is the client's responsibility to inform us if the vehicle is not fully fueled when received.

If the vehicle is unable to be returned full of fuel, we will provide a refueling service. We charge the cost of fuel, plus a \$45 service fee (at our discretion), to the credit card provided by the client. If the vehicle is not expected to be returned full of fuel for any reason, please inform us ahead of time to *possibly* avoid the service fee.
